The Grove School Students Eligible to Receive Meals under AB 130

The Grove School announced today its policy for serving meals to students under the California Universal Meals Program (AB 130) for the 2022-2023 school year. All Grove students are eligible to receive one healthy breakfast and one lunch at no cost each school day. Every child will be able to participate in these meal programs without having to pay a fee or submit a meal application. Breakfast breaks will be provided before school up until the school day starts. Nutritious lunches will be served every school day including minimum days.
