## 2022-23

#### May 1, 2023

- Andrew presented the LCAP (in progress) and the new graduation requirements.
- Board approved EPA funding resolution for this school year. Money went into salaries.
- Money was approved to conduct a feasibility study for a permanent building on the farm (kitchen, permanent bathrooms, classroom)
- Board is still in negotiation with the City of Redlands about new lease terms.
- Grove is switching banks to be able to move money into money market account and receive interest.
- June mtg was moved to June 21.
- Aimee was able to receive two grants for the kitchen, \$100,000 each. One of the grants will be used for already purchased kitchen equipment (trailer, fridge etc.)
- Hopefully some of the money can be used to build a storage behind the woodshop and at some point in the future expand the woodshop.

## February 6, 2023

- AAES presented to the board. They talked about what the club is doing including planning a Grove School Fair and Feed the Herd.
- The board voted and approved the 2023-24 calendar.
- The board approved the audit.

- Andy shared a draft plan to evaluate HoS. The evaluation includes a self-assessment as well as surveyed (students, teachers, staff). Discussion was moved to the April mtg.
- HoS report: Andrew submitted the LCAP report, went over lottery numbers, SPED state review and upcoming CDE review in April.
- PTG is in the process of becoming their own 501(c). Discussion about getting Farm to Fork money from Armantrout foundation as seed money for new 501(c).
  - Possible future projects: improve lighting (i.e. around stage area) and fence
- Finance report: audit and financials look good.
- LRP mtg: did not meet, still waiting for report from the city. Goes to council mtg. probably in March (lease renegotiation and adding structure to farm campus)
  - Construction committee: will meet again soon
